**The four points of Repatriation to be discussed and implemented by or before August 1<sup>st</sup>, 1994-95, thus fulfilling the Emancipation Charter of 1834 when all these Rights should have been given to us.**

1. Representation to the United Nations
2. Representation to the International Court of Justice
3. Representation to the Organization of African Unity (OAU)
4. Representation to Queen Elizabeth II to assist with Transportation and Compensation.

## **Agenda for Repatriation**

Action is envisaged through the following agents/agencies:

### **1. The United Nations**

The Government of Jamaica is being asked to put the matter on the agenda of the General Assembly, with reference to Articles 1 to 13 of the United Nations Charter.

As the Governor General himself said in a letter to E.A.B.I.C. Church of Salvation; the question of repatriation and compensation must be discussed at a global level. The matter has already been raised at that level but needs to be championed by a member government and support lobbied from among like-minded member nations.

The government of Jamaica should be the member state to champion the cause. If every member nation of the United Nations would contribute one ship, or whatever it can muster toward provision of such ship, the burden of cost would be shared and the burden of guilt by the white world would be eased. We are asking the Government of Jamaica to instruct its representative to the United Nations to lobby for this effort.

## **2. The International Court of Justice**

Our case had been referred to the – **ICJ** which, while it did not rule out the possibility of hearing the case, required sponsorship of a member state of the United Nations before entertaining our case.

We are calling on the Government of Jamaica as a recognized government and member state of the United Nations to sponsor our international Human Rights case for **fundamental freedom, redemption and repatriation** before the International Court of Justice in Hague.

## **3. The Organization of African Unity**

In letter dated November 8<sup>th</sup>, 1993 the Congress referred the matter to H.E. Salim Salim, Secretary-General of the O.A.U who is well aware of our propose agenda. Again, however, the matter needs to be championed by a recognized government in order to achieve implementation.

The Government of Jamaica as a observer to the O.A.U should request a country such as Ghana to push the case before the O.A.U. President of Ghana Flt. Lt. Jerry Rawlings, speaking before some 36 heads of state at the O.A.U was quoted by West Africa magazine as saying “We should and must find a way to include all the sons and daughters of Africa in building and moving our societies forward. In this respect. I would propose that the O.A.U should consider granting observer status to representative groups of Black Africans in the diaspora,” President Rawlings further called for the O.A.U Secretary-General to; “work out arrangements to open a way for them to make contributions to our common efforts.”

Accordingly, a specific request should be made through Jamaica's observer representative to the O.A.U for observer status to be granted to the E.A.B.I.C. Church of Salvation in the O.A.U.

Now that South Africa has a new black majority government and is likely to assume membership in the Organization of African Unity, it too can be called on to support the cause.

#### **4. Queen Elizabeth II**

The Government of Jamaica should make representation to Her Majesty Queen Elizabeth II to assist with transportation and compensation. The British Monarch has a responsibility to redeem and compensate the descendants of the Black Africans who were sent into slavery by her forbearers.
